

# Capacity Building (of VS)

Capacity refers to the ability of an individual, group, organisation or system to deliver intended outcomes, while capacity building refers to improving the ability of the entity to perform.' (Brown et al 20011)

Planning

- an internal) process

# Two complimentary projects funded by Australian Government

Enhanced capacities of countries in South-East Asia to detect, control and prevent the spread of priority Transboundary Animal Diseases (TADs)

- Island countries in SE Asia,
   Timor Leste and PNG
- Improve knowledge on priority diseases:
- VS capacity on surveillance, risk analysis, biosecurity, emergency preparedness,
- Improved regional coordination for TADs risk on the management

Australia-OIE One Health Partnership

- All ODA eligible countries in SE Asia, Timor Leste, PNG
- Improved regional health security by strengthening target countries' veterinary services capabilities using a One Health approach to anticipate, avert and arrest infectious disease threats

### **Expected Outcome**

 Contribute to improved regional health security by strengthening target countries' veterinary services capabilities using a One Health approach to anticipate, avert and arrest infectious disease threats

## **Objectives**

- Strengthen priority critical competencies identified in PVS Pathway missions.
- Develop veterinary and veterinary paraprofessional workforce through the use of international standards in their training – especially for rabies and AMR surveillance.
- Improve regional animal disease (including zoonoses) reporting via WAHIS for use by animal and human health decision makers

### Biosecurity

- Biosecurity on farms, including ToT
- ToT innovation, new techniques and infrastructure to improve biosecurity, animal welfare and production in commercial pig farming systems and minimise environmental impact
- communication and public awareness tools focusing on biosecurity

### Epidemio

- evidence to support claims of disease freedom
- TOT: to raise awareness in disease recognition, prevention and reporting of a broad range of stakeholders
- · Epidemio swine diseases
- · Participative epidemio

#### Surveillance:

- slaughterhouse and market surveillance
- Laboratory:
  - · Lab expertise and facilities
  - For swine diseases
  - Enhancing molecular diagnosis and FMD sampling

### Development of surveillance/control programmes and M&E

· Development of surveillance and monitoring programme

### Data management

- Data gathering, analysis, dissemination
- Information management systems
- Quality and verification of data entry or data sources
- Adoption and utilisation of information technology

### Risk analysis

- Risk analysis/management
- transboundary animal diseases spread by water ways, such as from illegal dumping of contaminated carcasses
- · Analysis of trade partners dossiers


