














Progression of the SEACFMD Countries in FMD PCP stages






Synergies with other TADs Control

- In training programmes focused on FMD; other TAD's such as ASF, AHS, LSD and Rabies have been embedded.
- Advanced GIS training organised during 27 Jul 30 Aug 2021 highlight of the training, country teams successfully applied Multi Decision Criteria Analysis (MCDA) tool and spatial risk assessment (SRA) methods to create risk maps for priority disease including AHS; ASF and dog mediated rabies.
- Epidemiological study design training (11 Nov –10 Dec 2021) The
 country projects based on example of ASF and Lumpy Skin Disease case
 scenarios have provided an opportunity for the participants to practice
 and develop skills to identify both the strengths and limitations of these
 epidemiological study designs.
- ASF Cross-Border Risk Assessment Training
- ToT on Outbreak investigation and Response
- Ongoing Infectious Disease Modelling Training



Progress on implementation of Sub-Commission and other Governance meeting Recommendations

25th Sub-Com meeting in December 2022

- Issue of animal and animal product movement control in the sub-region
 - Ongoing Animal Price Monitoring Study; Proposed for deleberations during the Upper Mekong Region Working Group Meeting
- Align regional and respective National FMD control plans with the SEACFMD Roadmap 2021 2025;
 - Ongoing (Regional plan will be endorsed in 26th Sub-Com meeting)
- the importance of molecular diagnosis to identify the circulating FMDV strain and of vaccine matching study; and high proportion of uncharacterized FMDVs
 - Ongoing: Regional Expert Group for FMD
- the quality of the different FMD vaccines used & status of FMD vaccination in the region
 - Survey on the implementation of FMD vaccination in SEACFMD countries conducted.

Progress on implementation of Sub-Commission and other Governance meeting Recommendations

25th Sub-Com meeting

- Surveillance and transparency: FMD surveillance is not always sensitive in the sub-region and the lack of transparency further limits the quality of the shared information. Higher quality, timely and transparent sharing of disease information would help countries to be better prepared for the potential risks;
 - > Session on fit for purpose surveillance organized with support of Dr David Paton
- Regional coordination: the OIE was requested to continue to organize and coordinate meetings, support
 epidemiological studies, and assist countries in the evaluation of potency and efficacy of vaccines;
 - ➤ Joint EpiNet/ LabNet meeting in Feb 2021; 24th NC meeting in July 2021; various capacity building programmes organized
- Evaluation of SEACFMD Campaign since its inception in 1997 in SEACFMD countries and in the region.
 - Ongoing





Progress on implementation of Sub-Commission and other SEACFMD Governance meeting Recommendations

EpiNet & LabNet Meetings 23 Feb 2021

- Characterization of FMD viruses from field outbreaks for tracing the source of the outbreaks, and share the genotyping results with the OIE SRR/OIE Ref Labs
 - ➤ Ongoing: Regional Expert Group for FMD
- organize regional studies to improve the knowledge on the gaps in the FMD reporting /national animal health information systems and approaches to improve
 - Ongoing Study to understand National Animal Health Information System
- To develop Guidelines for national procurement of good quality veterinary vaccines.
 - > Ongoing Consultant is working on the Guideline





Progress on implementation of Sub-Commission and other SEACFMD Governance meeting Recommendations

National Coordinators Meeting (29 to 30 July 2021)

- to finalize and implement the FMD activities of the National SEACFMD Roadmap Implementation Plan, aligned with their respective National FMD Prevention and Control Plan;
 - ➤ Ongoing Bilateral meeting with SEACFMD Members
- to finalize Regional SEACFMD Roadmap Implementation Plan with Indicators;
 - > Regional plan developed and proposed for endorsement
- to finalize the M&E framework for the SEACFMD Roadmap 2021-2025 and use this for reporting the progress;
 - ➤ M&E framework finalized with indicators for Outputs, Outcomes, Objective and Goal
