



# Background

- The collaboration between WOAH and FEI started at the Conference on international horse movement in Guadalajara, Mexico, in October 2011.
- It was formalised in 2012 and an Ad hoc Group was formed which met end of 2012 for the first time, followed by many other meetings
- The Ad hoc Group developed the WOAH principles that are today well known, such as EDFZ, HHP, diseases of importance for international horse movements, the Biosecurity Manual, and also looked at harmonising import health certificates at a global and regional level
- The Ad hoc Group also supported research projects which were identified by its members and WOAH member countries, e.g. AHS novel vaccines, glanders testing, dourine, EI, etc
- For the Asia and Pacific region, two events were of major importance:



## Workshop 18 – 20 February 2014, Hongkong

- Over 100 participants from the region: Veterinary Services, FEI and NFs, IFHA and national racing associations
- The Conference was preceded by a questionnaire survey on health certificates with all A&P countries 21 replied
- A report on the analysis of the different conditions for importing horses was produced and presented:
  - 43 diseases for certification
  - 50% of countries only have a T certificate
  - Only 3 countries were T certificate has lesser requirements than P certificate
  - A number of diseases, however, were identified to be of top priorty
- Other topics included:
  - Regulatory framework for horse movement
  - Collaboration between Veterinary Service and equestrian sports sector
  - Biosecurity and quarantine management
  - Implementation of the HHP concept
- Recommendations were formulated and the overall outcome summarised as:
  - Realised the increasing importance of equine industries and therefore the need for science based certification of equine diseases
  - Report of this meeting to be presented to the Regional Commission at the General Session in May 2014


