



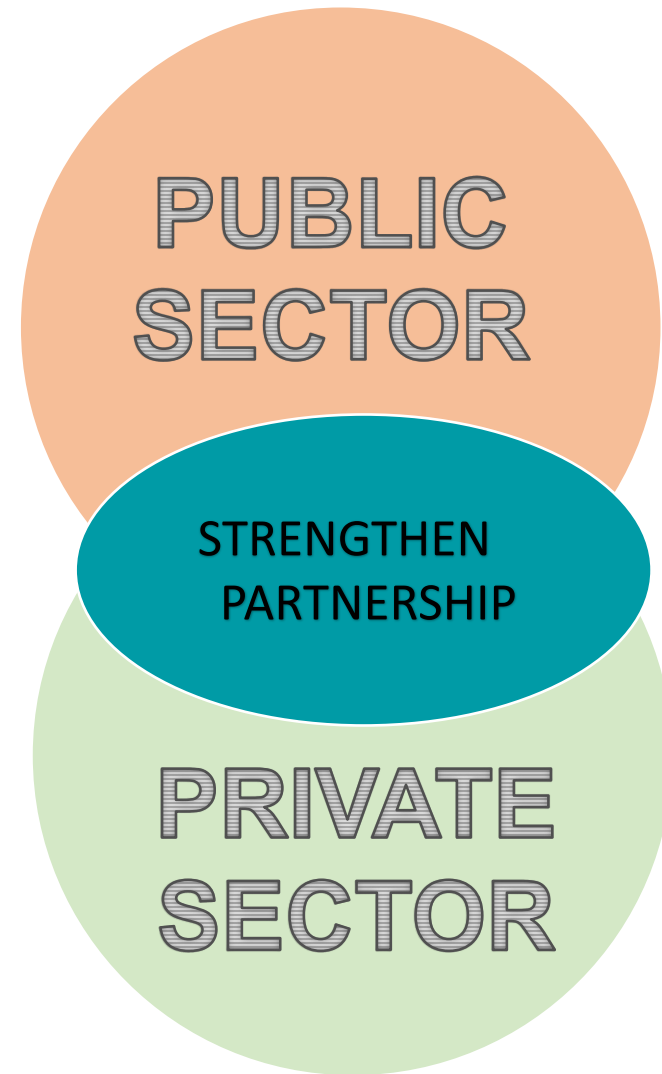

SECTION I : OVERVIEW OF FMD SITUATION

FMD Situation



- The number of clinical outbreaks (n=183) reported significantly reduced in 2022 compared to previous two years. [(2020, n=611), (2021 n=306)]
- New incursion in Indonesia.
- O/ME-SA/Ind2001e still dominantly circulating in the Region.
- Serotype A continuous circulation in Thailand.

(SEACFMD)**

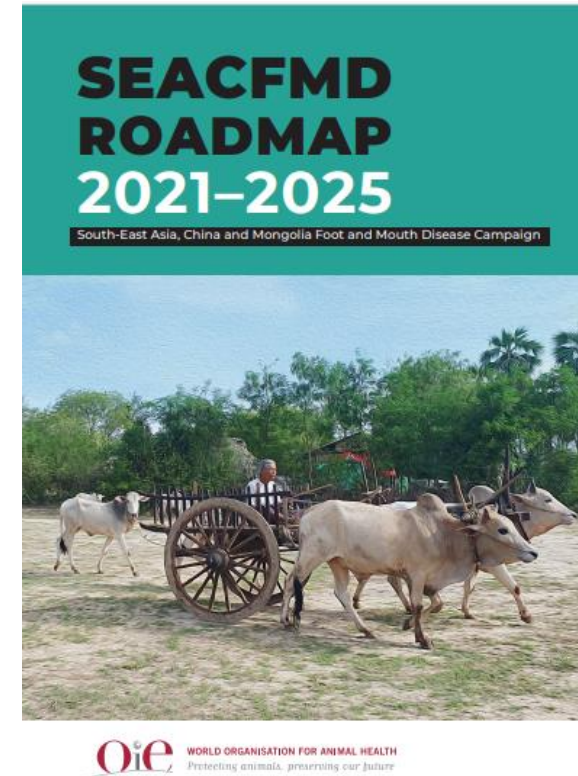
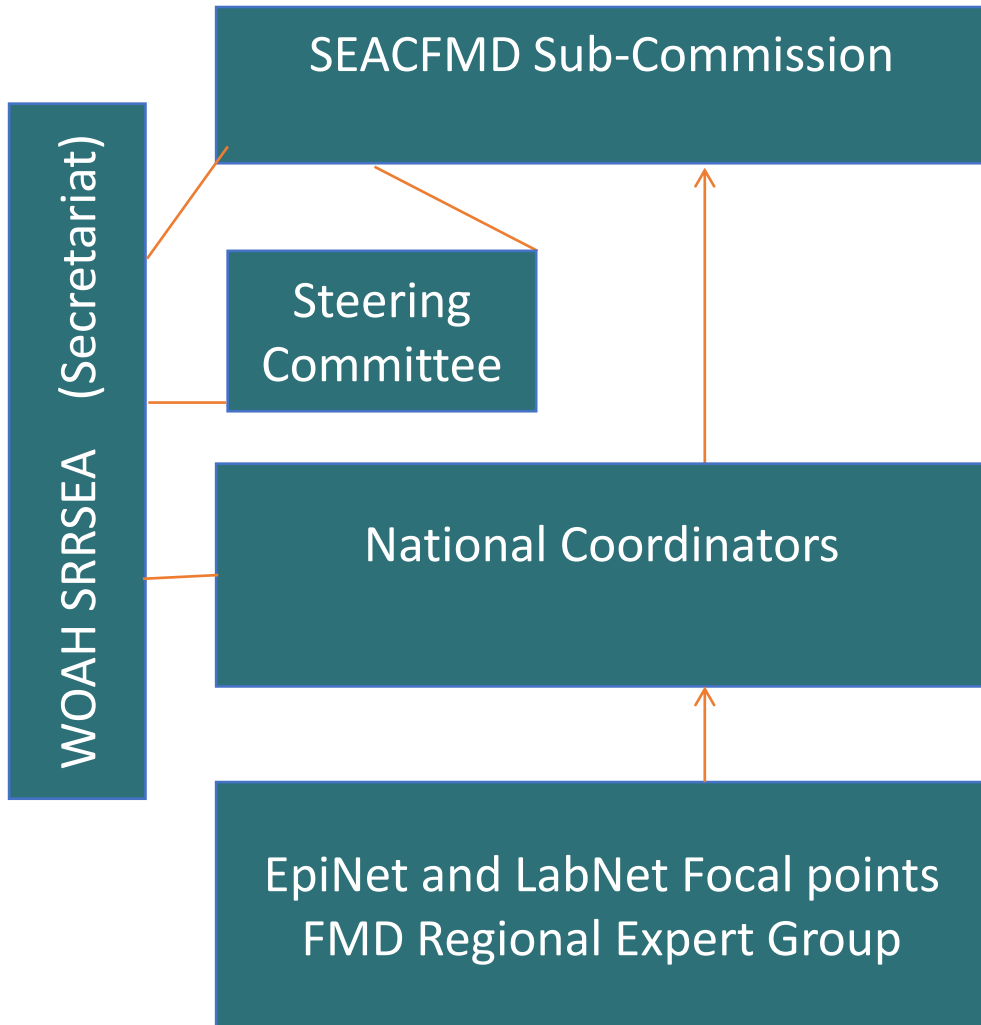

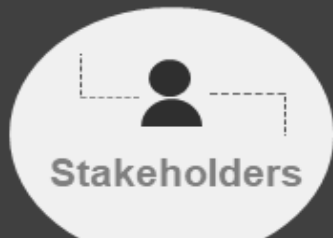
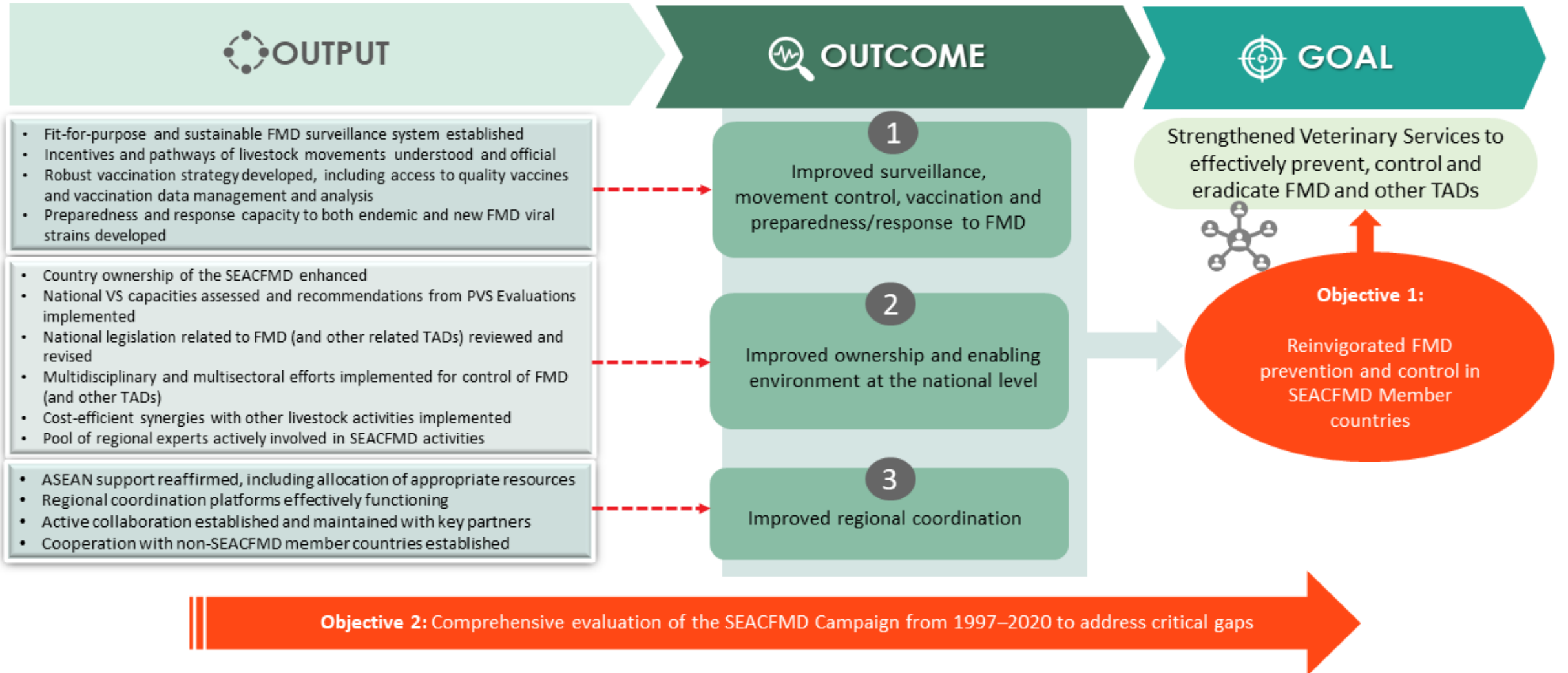
The SEACFMD campaign aims to increase productivity and economic output in the livestock sector by controlling and eradicating FMD in South-East Asia, China, and Mongolia

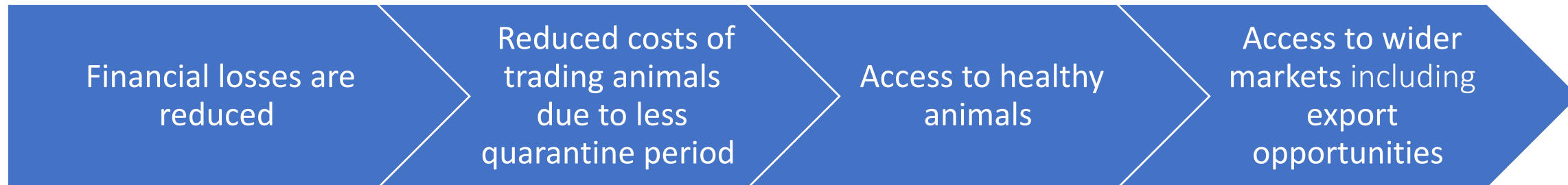

SECTION IV : PRIVATE SECTOR CONSULTATIVE COMMITTEE (PSCC)

PRIVATE SECTOR CONSULTATIVE COMMITTEE (PSCC) :

Following roles were identified

- Advise the Sub-Commission on ways to facilitate developments in the livestock sector that **support disease control and optimise production**, and to integrate the private sector into national and regional animal health systems.
- **Assist** in the **development of the regional plan for enhancing private sector involvement** in FMD control in Southeast Asia.
- Provide an **avenue for two-way communication and information exchange** between the Sub-Commission and private sector organisations in member countries
- Provide **strategic advice to the Sub-Commission on private sector involvement in FMD control** in SEACFMD countries.
- Advise on the **development and implementation of the plan** for enhanced private sector involvement in FMD control in SEACFMD Countries.
- Provide **policy and strategic advice to the Sub-Commission** during and between meetings of the Sub-Commission.
- **Advise on the development of the programme** for the private sector component of meetings of the Sub-Commission.

PSCC was established in 2007

PSCC (2019)

- With the intention to revive this initiative, [Private Sector Consultative Committee \(PSCC\) workshop](#) was organised on 28 Nov 2019 in Bangkok, Thailand.
- SEACFMD members, representative of private sector, and partners, and share [WOAH PPP Handbook on Guidelines for Public Private Partnerships in the Veterinary Domain](#)
- Members participated in PSCC (2019) : Cambodia, China, Indonesia, Lao PDR, Malaysia, Mongolia, Myanmar, Philippines, Singapore, and Thailand.



PSCC (2019) : Recommendation

- **PPP is crucial** to FMD control and prevention.
- Each country should **consider when and how a PPP can be supportive** of FMD control and prevention.
- In order to build a sub-regional network of traders and **each country should identify the one or two traders which can represent the traders** in their country. WOAHA would then ensure that this **network of traders is invited** to relevant meetings and activities.
- Access to good quality vaccine is a key challenge in South-East Asia, WOAHA will explore **how PPP could support a better access to good quality vaccine** in the region.
- **An enabling policy from the government to enhance engagement of farmers and traders to support vaccination** such as requiring that all animals for shipment should be vaccinated, and for traders to buy only vaccinated animals.

Examples in the region

Experiences shared during 24th SEACFMD National Coordinator meeting (July 2021) :

- Public Private Partnership (PPP) on **FMD vaccination** in Thailand (July 2021) presented by Thai Holstein Friesian Association. 'KHOK KHO Model' partnership with Milk Collecting Centres (MCC), and Department of Livestock Development (DLD).
- FMD vaccination implemented following the Public Private Partnership model: **Veterinary Services and Vaccine Producers** in Vietnam. The cooperation between Department of Animal Health BI/Merial and NAVETCO.
- Partnership of General Authority for Veterinary Services (GAVS) in partnership with the Private Veterinary Units (PVUs) to implement FMD vaccination, and its reporting.

Discussion

- Strengthen coordination and engagement of Veterinary Services (VS) and Private Sector
- Revisit and define the PSCC TOR
- Explore creation of sub-regional network of traders , private stakeholder mapping
- Review the implementation of recommendations of PSCC meeting held in 2019 particularly building traders and private sector network, and access to quality vaccine issues
- Exchange success stories (within and outside of the region) within and outside veterinary domain for understanding what is working to initiate the PPP, risks and incentives to sustain partnerships.
- Better understand the challenges, Private Sector, industry, Veterinary Services are facing and explore to initiate and sustain PPP and discuss possible solutions.
