World Café Outputs

Question: Surveillance and early detection

Q 1 . Please enlist the specific challenges/constraints to implement surveillance and early detection for ASF prevention and control ?

Answer: The Workshop identified the challenges in implementing surveillance and early detection of ASF, including lack of funding, lack of understanding of ASF, lack of access to and expertise on the use of rapid field and confirmatory tests, the resistance of farmers to sampling, low virulence and sub-clinical of ASF, surveillance of wild pig not done, and lack of animal health information system.

Question: Surveillance and early detection

Q 2. Please enlist your suggestions /solutions to improve ASF surveillance and early detection?

Answer: The workshop proposed solutions to improve the surveillance and early detection of ASF, including the conduct of information and education campaigns to raise public awareness, engage partners for funding support, develop guidance on the tests to use, strengthen capacity for laboratory diagnosis (PCR, sequencing), improve access to reference laboratories, explore laboratory twinning projects, conduct training of trainers in disease surveillance and detection, enhance collaboration across government agencies (wildlife and environment), develop a monitoring system for wild pig population, exchange surveillance information on a regular period, and establish insurance system for pig.



Question: Prevention of ASF of further spread and introduction in ASF free compartments/zones

Q 1 . Please enlist the specific challenges/constraints to prevent further spread of ASF and its introduction to ASF free compartments /zones ?

Answer : The workshop identified the key challenges towards preventing the spread of ASF in the ASF-free zones including resistance to the policy by stakeholders, limited movement control, the policy at the local level not being fully functional, and lack of registration system on livestock resulting in lack of knowledge of pig population.



Question: Prevention of ASF of further spread and introduction in ASF free compartments/zones

Q 2. Please enlist your suggestions/solutions to prevent further spread of ASF and its introduction to ASF free compartments/zones ?

Answer: The Workshop proposed solutions to prevent the spread of ASF through the implementation of compartmentalisation guidelines, strengthening local governance and enforcement of law in ASF prevention and control, and promoting multi-stakeholder collaboration.

Question: Response

Q 1 . Please enlist the specific challenges/constraints to implement response to ASF outbreaks ?

Answer: The workshop identified the key challenges to implementing response to ASF outbreaks, including: delayed reporting, lack of human and financial resources to conduct diagnostics, logistical and access to outbreak areas, lack of harmonised legislation between national and local government, lack of compliance and coordination among stakeholders, limited information sharing, no compensation or indemnification, misinformation and disinformation about the disease, difficulty in the destruction and disposal of animals (manpower, logistic and location).

Question: Response

Q 2. Please enlist your suggestions /solutions to improve response capacities to ASF outbreak?

Answer: The workshop proposed solutions to improve response to ASF outbreaks including: strengthening reporting system by providing incentives for reporting and developing a digital system for reporting, well-consulted legislation, expanding consultation to other key stakeholders, conducting a After Action Review of outbreak response, promoting evidence-based responses through data collection and analysis, strengthen slaughterhouse surveillance, and develop national/regional of ASF preparedness plan.

Question: Recovery

Q 1 . Please enlist the specific challenges/constraints to recover from the impact of ASF ?

Answer: The workshop identified key challenges to recover from ASF outbreak including lack of comprehensive guidelines and regulations or standards for restocking, long survival of the virus in the environment, lack or incomplete information on the value chain, lack of coordination and communication at the country level, lack of sources of healthy pig, fear of restocking (preference of farmers on the type of pig to restock), lack knowledge on biosecurity etc.

Question: Recovery

Q 2. Please enlist your suggestions /solutions to facilitate the sustainable recovery from ASF ?

Answer: The workshop proposed solutions to facilitate sustainable recovery from ASF outbreak, including: the conduct of risk assessment at the farm and community level, develop comprehensive restocking guidelines and regulations, conduct value chain analysis, set-up community-based approach to re-educate educating farmers on biosecurity measures, effective decontamination with right disinfectant, accreditation/certification for ASF farm, provide an incentive for re-stocking, explore suitable visible vaccine candidates.
