











GF-TADs South East Asia Update





GF-TADS Meeting (ASEAN)

- Held in Bali, 23 April 2019, back to back with 27th Meeting of the ASEAN Sectoral Working Group on Livestock (ASWGL)
- Recommendations from the 27th ASWGL on GF TADs:
 - Encouraged ASWGL Chair to actively participate in the GF-TAD RSC Meeting in order to ensure that views and needs of ASEAN and AMS are appropriately represented, including linkages with existing ASEAN initiatives;
 - 2. Requested FAO and OIE, with support from GF-TAD Regional Secretariat and ASEAN Secretariat, to continue to support ASEAN and AMS on relevant activities;
 - 3. Requested FAO and OIE to provide updates on relevant activities at the subregional GF-TAD Meeting for ASEAN, which will be held every two years in conjunction with ASWGL meeting following this year arrangement;
 - 4. Supported ASEAN initiative to review the ASEAN priority animal diseases taking into consideration relevant global and regional initiatives and situation;
 - 5. Took note and supported FAO and OIE to increase PPR preparedness in the region and eventually request the official recognition of their free status.





Priority Diseases

ASEAN Priority Disease and Current Status/Activities:

1. Foot and Mouth Diseases (FMD)

 Working closely with OIE to incorporate relevant activities to be included on SEACFMD Roadmap 2021-2025 and identifying key FMD related projects/programmes/funding for the region.

2. Avian Influenza (AI) and Newcastle Diseases (ND)

- Reviewing the implementation of the Roadmap to an HPAI-Free ASEAN
 Community by 2020 and ways Forward Towards Prevention and Control of Avian Influenza in ASEAN
- Conducting regional assessment study on Newcastle Disease in ASEAN to get an overview of the current situation, gaps and needs for regional cooperation.



Priority Diseases

ASEAN Priority Disease and Current Status/Activities:

3. Classical Swine Fever (CSF) and Porcine Reproductive and Respiratory Syndrome (PRRS)

 Review the strategy and action plan of ASEAN Regional Strategy on Control and Prevention of CSF and Other Swine Diseases 2016 – 2020

4. Brucellosis

 Conducting workshop on cross border animal disease control and movement control and Stakeholder Consultation to pilot the Stepwise Brucellosis Control Framework

5. Rabies

 Review of ASEAN Rabies Elimination Strategy (ARES) and propose to update the document based on the current dog mediated rabies elimination by 2030.



Emerging TADs

Other diseases of importance to ASEAN

1. African Swine Fever

ASEAN Member States support the implementation of the FAO
 Technical Cooperation Project – Emergency (TCP-E) for ASF
 emergency preparedness and response in South East Asia.

2. Peste des Petits Ruminants (PPR)

 Developing ASEAN regional action plan for PPR eradication, in alignment with the global strategy. The action plan will include also a study to assess official PPR status of AMS.



Work during COVID-19

Impact of COVID-19 on priority TADs and activities in controlling TADs

- Field activities is limited (surveillance, outbreak investigation, vaccination, etc.)
- Some activities have to be postponed or rescheduled (surveillance, vaccination, training, public awareness etc.)
- Laboratory activities (testing) continued with some limitation (some lab is still operated)
- Some issues with distribution of logistic related to disease control
- Trade/movement of animal and animal product limited/disrupted (international and national)
- Coordination is continued through online basis (limitation in some area)
- Less illegal trade and movement of animal and animal product



Future plans

- Strengthen cooperation with international organization (FAO/OIE) and donors to tackle the TADs and ASEAN priority diseases
- Continue the regional work on ASEAN priority diseases
- Expedite the operationalisation of ASEAN Coordinating Centre for Animal Health and Zoonosis (ACCAHZ)
