
Responsibilities of LBVD

- To carry out animal health development,
- To promote livestock development,
- To prevent and control contagious diseases of animals,
- To inspect imported animals, animal products, animal feed & Veterinary pharmaceuticals,
- To issue recommendation and Veterinary Health Certificate for the exported animals, animal products and animal feed,
- To protect animals by law from being ill-treated.



Organization Chart of LBVD






Organization Chart of Economic Division



ODuties and Functions of SPS Enquiry Point in Myanmar

- to answer all reasonable questions regarding SPS measures from domestic organizations and other WTO Member countries,
- to provide relevant supporting documents,
- to allow trading partners to be aware of and to meet expectations and trade requirements more readily thus contributing to the trade facilitation process and increase trade activity in both imports and exports,
- To provide the information about Myanmar's and other country's measures, regulations, standards, test procedures, certification requirements, etc. which are requested by the domestic, regional and international stakeholders.






- The evaluation of likelihood of entry, establishment or spread of disease within the territory of importing countries according to SPS measures.
- The evaluation of potential or adverse effects on human or animal health arising from the presence of additives, contaminants, toxins or disease-causing organisms in food, beverages or feedstuffs.

Map of Animal Check Point and Quarantine Station






Objectives of Quarantine Station

To control Animal Transboundary Diseases,

- To check all data for animals such as health certificate, vaccination record) and to make health investigations,
- To ensure import and export animals are free from diseases.



Control of Animal Movement

- Livestock Breeding and Veterinary Department is responsible to control the movement of animal and animal products in the country & at the border area;
- According to the Animal Health and Development Law and It's Directive-
- Officers from LBVD check the health status of animal and issue veterinary health certificates for animal movement from one region to another, and
- Animal movement between State/ Division/ Township is controlled by local veterinary officer and authorities.

Kutkai Animal Quarantine Station

- Kutkai Animal Quarantine Station (Shan State) is internationally certified and can check for such animal diseases that is important in exporting livestock.
- The station is well equipped and will perform the lab work, meeting rooms, animal enclosures, and other measures necessary before exporting to another country.
