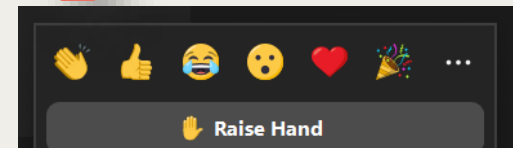
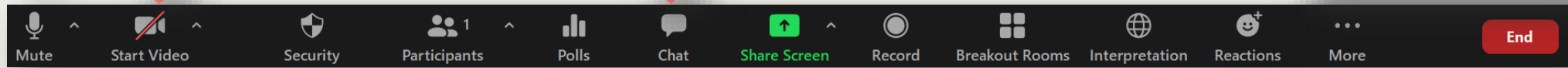
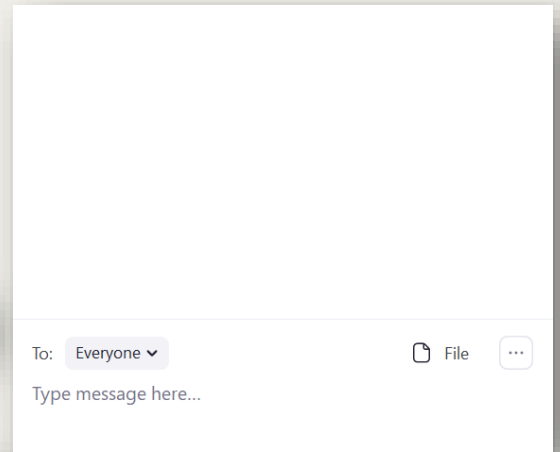
# Zoom function
