Veterinary Public Health Ordinance 1999

- Import only from FMD Free Countries/Zones
- Interdivision animal movement control
- Biannual audit to Allana & AL Quresh Buffalo Meat Abattoir/Plant
- Farm, abattoir, processing plant, feed mill licensing
- Gazette divisions bordering Kalimantan as FMD Control Area

PERMIT TO REMOVE ANIMAL IN AN INFECTED AREA
(Section 36)

PPES TERNAK SENDIRIAN BERHAD of Lot 1641, Block 5, Sentah Segu Land, 94200
Siburan, Sarawak (address) is hereby authorised to remove the animals or fish specified
hereunder into/out of the infected area, namely: Serian subjected to the conditions

1. This permit is granted for one consignment only to specified destination.
2. This permit is valid from the date issue and will expire in **fourteen (14)** days.
3. This permit must be surrendered to nearest Veterinary Office upon arrival together with the Delivery Order or Note.
4. Movement of cattle into the declared Food and Mouth Disease (FMD) Disease Control Area is subjected to the following additional conditions:-
 - (a) The transporter is allowed to collect and transport cattle from one farm or one source only.
 - (b) The transporter is advised to thoroughly wash and disinfect the vehicle after delivery of the consignment or before collection of subsequent consignment.
5. You are to take all necessary precautions to prevent introduction of Food and Mouth Disease (FMD) virus into your farm.
6. Advance notice of arrival of the consignment to be made known to the Divisional Veterinary Office two days in advance.
7. Failure to comply with the above will result in penalty under Section 91 of Veterinary Public Health Ordinance 1999.

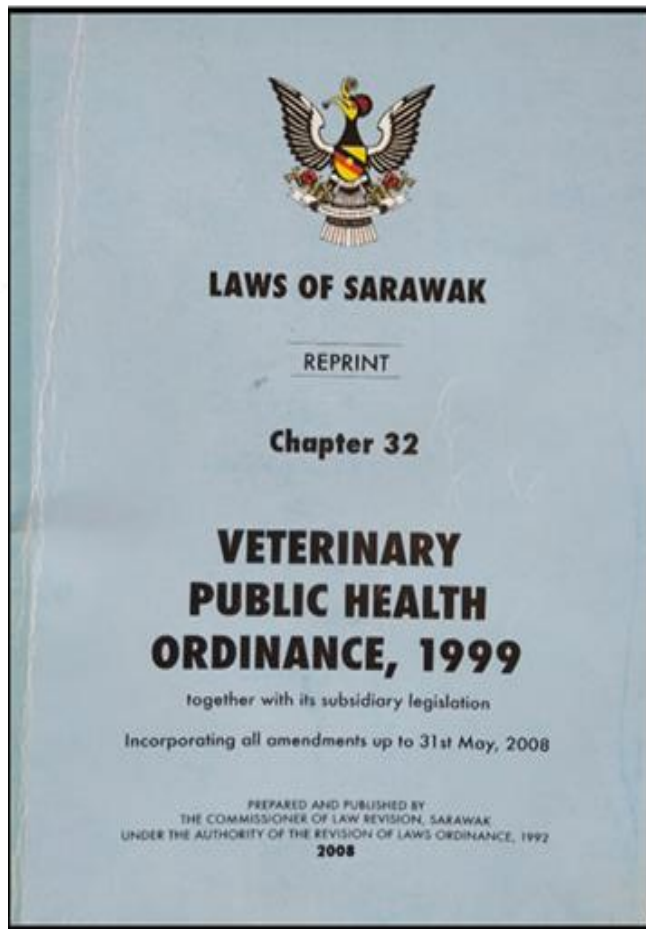

VETERINARY PUBLIC HEALTH ORDINANCE, 1999
DECLARATION OF FOOT AND MOUTH (FMD) DISEASE CONTROL AREA
(MADE UNDER SECTION 35(1) (b))

In exercise of power conferred by Section 35 (1) (b) of The Veterinary Public Health Ordinance, 1999 (Cap. 32), The Minister for Modernisation of Agriculture and Regional Development, hereby makes this Order and declares **Kuching, Serian, Sri Aman, Miri and Limbang Division** as Foot and Mouth disease control areas. This Order shall require and impose all necessary control measures and any other provisions that are necessary to prevent the introduction of Foot and Mouth disease into Sarawak.

This Foot and Mouth disease control order shall remain in force until such time the Order is revoked.

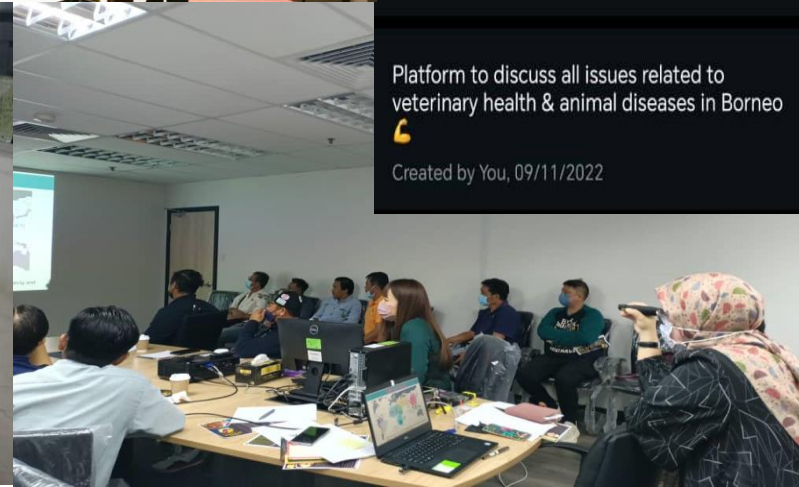
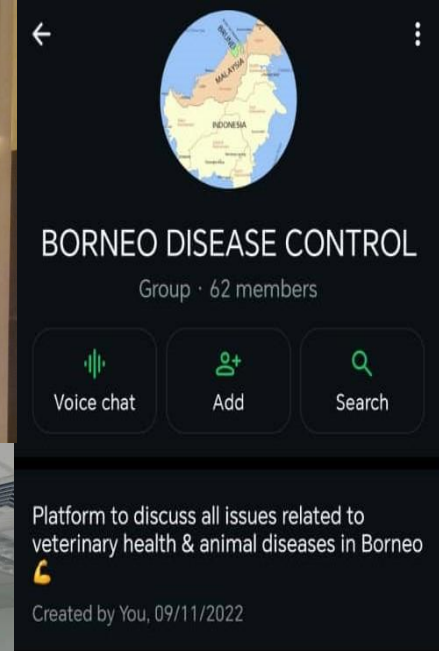
