1. OHP FRAMEWORK FOR 2021-2025

- Re-signed in March 2021, now there are 32 official members
- March, 2022: Approved the National Multi-sectoral Plan on One Health.



2. OBJECTIVES OF OHP FRAMEWORK

Overall objective:

“To minimize the risks of zoonotic pathogens and environmental agents’ spillover and antimicrobial resistance by improving multi-sectoral One Health collaboration”.

Six specific objectives were identified, including:

1. *To strengthen the institutional capacity and human resources*; to establish a framework and forum for multi-sectoral dialogue and collaboration for minimizing the spillover risks at human, animal, and ecosystem interfaces.
2. To minimize the risks of emerging and transmitting *new zoonotic disease pathogens* due to the biological, environmental, and human behavior impacts.
3. To step up the governance of *food safety*; management and supervision of *antibiotic use and to curb antimicrobial resistance*.
4. *To minimize the human health impacts of some zoonoses* (as prioritized in the Joint Circular 16/2013/TTLTBYT-BNN&PTNT dated 27 May 2013) and *other recurrent diseases* to human health.
5. *To enhance the mobilization of resources for recovery*, reconstruction, and the management of risks caused by emerging and resurging dangerous diseases.
6. To strengthen *the control and management of environmental factors* that have human’s health impact

3. STRUCTURE

1. The Steering Committee: Co-Chaired by 03 Ministerial Leaders of MARD, MoH and MoNRE
2. The multisectoral Technical Coordination Task Force (DAH, DLP, DoFC; GDPM, D of Environment Population Control, Department of Biodiversity Conservation, Department of Market Management etc...)
3. High level One Health Partnership annual Forum co chaired by 3 Leaders of 3 Ministries
4. Technical Working Groups (TWGs) and Technical and Policy Research Groups (05 working groups)
5. The Secretariat (03 national coordinator from MOH, MONRE, MARD)

The Secretariat is located within the International Cooperation Department of MARD. The Secretariat is responsible for assisting the Steering Committee and the Multisectoral Coordination Task Force to carry out all activities of the approved annual work plans

6- FUNCTIONS OF THE TECHNICAL WORKING GROUPS

- (1) 5/5 technical working groups have been organized on a quarterly and annual basis in 2024
- (2) Being an open mechanism, participatory management; co-owned through a voluntary and rotating co-chairing mechanism. => acknowledging the dynamic, active and effective chairing of the Department of Animal Health, Department of Livestock Production, and National Authority for Agro-Forestry-Fishery quality, processing and Market Development with 01 international partner.
- (3) Connecting a network of stakeholders to share and exchange on specific technical contents, mechanisms, policies, research results and One Health Projects in the key areas of the One Health Master Plan.
- (4) Proposing changes to policy mechanisms related to the key areas of the Partnership Framework;
- (5) Overcoming difficulties and obstacles in the implementation of One Health initiatives and Projects in Vietnam.
- (6) Proposing priority cooperation activities and programs
- (7) Mobilizing financial and intellectual resources to implement tasks in key areas;
- (8) Strengthening institutional capacity for multi-sectoral coordination in key areas.

7- OTHER COORDINATION

1. Coordinating multi-sectoral national consultations to prepare One Health Project Proposals (Techniques and Procedures)
2. Coordinating scientific conferences, policies, programs, communication events on One Health, International One Health Day... etc...
3. Connecting, coordinating cooperation, participating and supporting regional and international One Health networks/organizations such as: World Organization for Animal Health (WOAH), Global Health Security Agenda (GHSA), ASEAN One Health Partnership initiative, nature4health; EcoHealth, Prezode, One Health Alliance, OHI-CGIAR...
4. Proactively seeking and cooperating with multiple parties to mobilize resources from bilateral partners such as EU, France, US, UK and international and regional funds to implement One Health initiatives such as GEF, GCF, Nature4health...
5. Promoting private sector participation in the One Health Partnership Framework through five working groups.

8- ONE HEALTH PROJECTS (UP TO DECEMBER 2024)

- About more than 100 OH projects have been, are being implemented and are about to focus on disease safety, interdisciplinary surveillance, antimicrobial resistance (AMR), prevention of illegal wildlife trade and consumption (Agriculture and Health)
- **Major donors** to the epidemic sector: United States, UK, Germany, EU, France, South Korea...
- **Main challenges:** Limited counter part fund, depends mostly on international grants.
- **Areas of activity requiring increased investment include:**
 - + Food safety;
 - + Biosafety in livestock;
 - + Antibiotic resistance in livestock, aquaculture and the environment.
 - + Grassroots One Health Network (KfW, USAID)
 - + Building cross-sectoral and cross-level One Health capacity.
 - + Strengthening cross-sectoral coordination in preventing illegal wildlife trade and consumption and combating antimicrobial resistance
 - + Environmental factors affecting human and animal health;
 - + Communication efforts on One Health and core areas, etc.
 - + Digital technology on One Health
 - + Emphasizing plant health and soil health

9- COORDINATION PLAN FOR 2025

1. Continuing to promote the important role of multi-sectoral Working Groups;
2. Strengthening the activities of the Vietnam One Health network with the region and the world;
3. Reviewing and adjusting the national plan on One Health;
4. Making reports to the Government on the results of 5-year operations; Make recommendations on mechanisms, policies, etc.
5. Continuing to accompany international partners to develop and complete One Health Project Proposals to mobilize resources for Vietnam;
6. Advising partners on procedures and regulations for compliance with receiving, implementing and completing the Project.
7. Strengthening the participation of stakeholders (Ministries and sectors such as the Ministry of Education; Information and Communications; Ministry of Foreign Affairs, etc.; private sector)
8. Continuing to be a bridge, creating forums for stakeholders on One Health;
