


Livestock Population in 2024 (estimated)

• Buffaloes: 2.07 millions





MEMORANDUM ON THE CONSTRUCTION REQUIREMENTS OF FOOT AND MOUTH DISEASE FREE ZONE WHERE VACCINATION IS PRACTICED BETWEEN THE MINISTRY OF AGRICULTURE AND RURAL DEVELOPMENT OF THE SOCIALIST REPUBLIC OF VIET NAMAND THE GENERAL ADMINISTRATION OF CUSTOMS OF THE PEOPLE'S REPUBLIC OF CHINA

The Ministry of Agriculture and Rural Development of the Socialist Republic of Viet Nam and the General Administration of Customs of the People's Republic of China (thereinafter referred to as "the two sides"), for the purpose of promoting bilateral trade in artiodactyla animals and their products between the People's Republic of China and the Socialist Republic of Viet Nam, the two sides through friendly discussions, have agreed to sign this Memorandum on the requirements of Foot and mouth disease free zone where vaccination is practiced. This Memorandum is acting in accordance with the applicable laws and regulations of their respective countries, and it is not intending to create any legally binding obligations upon the two sides under international laws. This Memorandum is developed based on the mutual agreement between the two sides about the basic requirements for Foot and mouth disease free zone in the Annex.

This Memorandum is signed in , on December 12th, 2023, in duplicate, each in Vietnamese, Chinese and English languages, in case of

disagreement in the interpretation of the text, the two sides will refer to the text in English language.

This Memorandum will take effect on the date of signature.


