FMD situation in 2024 and 2025

- The Philippines is officially recognized by the World Organisation for Animal Health (WOAH) as a country free from FMD where vaccination is not practiced since May 2015.
- According to the Resolution No. 13 (approved during the 92nd General Session, May 2025)









Output 1.2 Incentives and pathways of livestock movements understood, and official animal movements promoted

 13 eligible countries are accredited to export live animals (cloven-footed) and Genetic Materials into the Philippines

Output 1.3 Robust vaccination strategy developed, including access to quality vaccines and vaccination data management and analysis

The Department of Agriculture (DA) has allotted PhP14M (\$245,504.20)
 for the procurement of FMD Vaccine Buffer stock





Output 1.4 Preparedness and response capacity to both endemic and new FMD viral strains developed.

 FMD Tabletop Simulation Exercises were conducted in major island clusters of the country (Luzon, Visayas, and Mindanao) last 2023-2024











Outcome 2: Improved ownership and enabling environment at national level

 The Bureau of Animal Industry (BAI), as the competent authority, through the Animal Health and Welfare Division (AHWD), leads the FMD Prevention and Control Program. The DA Regional Offices and Local Government Unit (Provincial Veterinary Office) serve as FMD coordinators. The BAI intends to revive the National FMD Task Force (NFMDTF) and convene the group annually.

SUBJECT: GUIDELINES ON GRANTING CASH ASSISTANCE FOR FARMERS AFFECTED BY EMERGING, RE-EMERGING, AND TRANSBOUNDARY ANIMAL DISEASES

WHEREAS, pursuant to Act No. 3639, the Bureau of Animal Industry (BAI) is mandated, among others, to promote the development of the livestock industry of the country;

WHEREAS, Administrative Order No. 08, Series of 2021 was promulgated by the Department of Agriculture (DA) to improve animal disease reporting and outbreak investigation for better scope and comprehension of the animal disease situation in the country, and to strengthen the implementation of the prevention, control, and eradication programs for emerging and re-emerging animal diseases;

WHEREAS, Memorandum Circular No. 30, Series of 2024 was issued by BAI to rationalize animal disease reporting and harmonize the list of priority animal diseases, thereby strengthening national prevention, control, and eradication efforts through the development of animal health programs and streamlined disease reporting mechanisms;

WHEREAS, DA Administrative Order No. 37, Series of 2020 and DA Administrative Order No. 10, series of 2024 were issued to alleviate production losses and encourage early reporting by farmers of actual or suspected cases of diseases of their animals, thus avoiding further spread of animal diseases;

WHEREAS, early reporting of animal-borne diseases is crucial for an efficient and wellcoordinated response, including the immediate implementation of control measures to mitigate the impact of disease outbreaks:

WHEREAS, the DA recognizes the need for a proactive approach by formulating guidelines for indemnification of farmers affected by emerging, re-emerging, and transboundary animal diseases, ensuring consistency with government accounting and auditing principles and the objective of the government for a transparent and legal release of cash assistance to affected farmers:

WHEREAS, during the implementation of cash assistance, there have been reports of delayed payment and clamor for higher compensation for affected farmers to effectively control the disease; and delay in detection, case confirmation or stamping-out actions can lead to failure of the whole eradication program; and

Output 2.1 Country ownership of the SEACFMD Campaign enhanced.

- Development of the FMD Preparedness Guidelines (for approval of the DA Secretary).
- FMD included in the recently developed Guidelines on indemnification for farmers affected by emerging, reemerging, and transboundary animal diseases.

MEMORANDUM CIRCULAR

Series of 2025

SUBJECT:

CATEGORIZATION OF PRIORITY ANIMAL DISEASES LISTED BY THE BUREAU OF ANIMAL INDUSTRY

WHEREAS, the Bureau of Animal Industry (BAI), under Act No. 3639 s.1930 and Executive Order No. 292 s.1987, is mandated to investigate, study, and report on the cause of dangerous communicable animal diseases, as well as to develop and implement measures for their prevention, and promote the development of livestock industries;

WHEREAS, the emergence of animal diseases is considered a major threat to animal health and productivity, food security, public health, and global trade, with studies estimating that 20% of the animal production losses are linked to animal diseases;

WHEREAS, in the Philippines, there has been series of activities to update priority animal diseases aligned with international guidelines from the World Organisation for Animal Health (WOAH), Association of Southeast Asian Nations (ASEAN), and Food and Agriculture Organization (FAO) of the United Nations, as well as policies adopted from institutions such as European Union (EU) Commission;

WHEREAS, the BAI Memorandum Circular (MC) 30 s.20241 was issued to identify BAI's priority animal diseases using a multi-criteria decision analysis and informed by experts' judgement from BAI technical officers on animal health, border control, and animal disease diagnostics, evaluating over 100 reportable WOAH diseases based on zoonotic potential, socio economic impact, urgency of disease reporting, and laboratory capacity;

WHEREAS, to enhance the strategic allocation of veterinary resources, there is a need to further refine and organize this list into a categorical framework;

NOW, THEREFORE, to provide clear guidance for the National and Local Animal Health Authorities in the efficient and effective implementation of animal disease prevention and control programs, border control measures, and animal disease diagnosis, the priority animal diseases are categorized as follows, along with corresponding strategies for the reference of all concerned:

ARTICLE I GENERAL PROVISIONS

Section 1. COVERAGE

RECONSTITUTION OF THE BUREAU OF ANIMAL INDUSTRY TECHNICAL WORKING GROUP (BAI-TWG) FOR THE REVISION OF FOOT AND MOUTH DISEASE EMERGENCY PREPAREDNESS PLAN (FMD-EPP)

In the exigency of the service, prescribed responsibility of BAI in accordance with Act No. 3639, the Special Order No. 127, Series of 2024, or the "Creation of the Bureau of Animal Industry Technical Working Group (BAI-TWG) for the Revision of Foot and Mouth Disease Emergency Preparedness Plan (FMD-EPP)," public interest, and threats of Transboundary Animal Diseases (TADs), a TWG is established to facilitate a comprehensive review and update of the existing FMD-EPP with the following composition:





Key challenges and lessons learnt

CHALLENGES	SOLUTIONS
Shift of prioritization due to outbreaks of other economically important diseases	Realignment of resources from other animal disease programs
Newly appointed personnel in animal health primarily possess technical knowledge in FMD	Conduct of capacity building activities
Only the National Laboratory is capacitated to test for FMD using NSP-ELISA	Capacitation of Regional Laboratories
Some localities do not have official veterinarians	Request intervention of the national offices to direct localities to comply with the existing law
Outdated guidelines on detection and response to FMD	Updating of the guidelines





Key challenges and lessons learnt

CHALLENGES	SOLUTIONS
Lack of cold storage facilities and reefer vans for meat preservation in case of emergencies	Timely completion of the DA Cold Examination Facility in Agriculture (CEFA)
TAD outbreaks not considered in declaration of State of Calamity in Local Government Units	Amendment to the criteria by the National Disaster Risk Reduction and Management Council
Need to further strengthen coordination with stakeholders and academe	BAI to spearhead activities involving them





Ways Forward

- Reassessment of risk levels of Provinces in the country in relation to possible FMD incursion and spread
- Capacitation of regional laboratories
- Continuous collection of Negative Monitoring Reports
- Publication of the recently drafted 'FMD Preparedness Plan (2025)'
- Simulation Exercises
- Implementation of the FMD Communication Plan





Proposed Priority Actions for SEACFMD 2026-2030

- Development/ Enhancement of the Regional Communication Plan for FMD
- Standardize methodologies for regional simulation exercises
- Face-to-face retooling activity for the SEACFMD Coordinators
