Recommendations from the workshop

Veterinary Council of India (VCI)

- 1. Oversee communications for collaborations among the VEEs both at regional and national levels
- 2. With support of the OIE, explore ways to establish a standing platform for a subregional network of VEEs and VSBs in South Asia
- Consider consultation with OIE veterinary education experts while reviewing the MSVER towards OIE Day 1 competencies of veterinary graduates
- 4. Consult experts or other competent persons from agencies/organisations/sectors more closely in development and revision of the veterinary curriculum to ensure imparting of sufficient skills and knowledge to "Day 1 graduates" keeping pace with changing science and sector-specific skill requirements at the workplace
- 5. VCI to consider the revision of veterinary core curriculum to enable the "Day 1 graduates" to be competent in skills and knowledge regarding emerging issues such as AMR, responsible and prudent use of antimicrobials at the veterinary workplace

Veterinary Education Establishment (VEEs)

- 1. Continue to improve quality of education by using OIE guidelines in the curriculum
- 2. Improve existing internship programs to impart better skills among "Day 1 graduates" as required by different stakeholders
- 3. Prepare for imparting effective veterinary education during pandemic situations as learned from the current COVID-19 pandemic
- 4. **GADVASU** to share their experience and expertise from OIE twinning project including support training of other VEEs in India
- 5. VEEs to ensure inclusion of topics on AMR, responsible and prudent use of antimicrobials in the curriculum towards competency of the "Day 1 graduates"





Veterinary Services (VS)

- Further enhance communication with VCI and VEEs regarding career opportunities, knowledge and skills needed by the workforce, and to assist with the training of sectorspecific skills
- Prepare for delivery of veterinary services during pandemic situations as learned from the current COVID-19 pandemic including sharing of resource and experiences under One Health
- 3. Veterinary Services including DAHD, VCI, VEEs, State Veterinary Departments, State Veterinary Councils, NDDB, Milk Federations, ICAR, NAVS, Veterinary Associations etc. in India to organize seminar and workshops, at various levels, highlighting the roles and responsibilities of veterinarians and veterinary paraprofessionals in fostering responsible and prudent use of antimicrobials

World Organisation for Animal Health (OIE)

- 1. Continue to facilitate or promote activities to improve quality of veterinary education throughout Asia and the Pacific, including the sub-region of South Asia
- 2. OIE to support capacity building through workshops and related activities on AMR
