Next steps: Consultation meeting summary report

May 2023

- Nossal Institute to prepare and submit draft consultation meeting summary report by 22 May 2023; ASEAN Secretariat to circulate to meeting delegates.
- Meeting delegates to review and provide feedback to ASEAN Secretariat, and/or to endorse the draft summary report by 5 June 2023.

[Note: Endorsed summary report to be elevated to ASWGL and AHC 2 for notation and further guidance, as part of report of Lead Countries on progress on ARES during:

- 31st Meeting of ASWGL, July 2023
- 8th Meeting of AHC 2, October 2023]

Next steps: Updated version of draft Revised ARES

May 2023

- Meeting delegates to further review the draft Revised ARES and submit inputs to ASEAN Secretariat within two weeks after the meeting (by 22 May 2023).
- Nossal Institute to review inputs and produce an updated version of draft Revised ARES by 5 June 2023.

Next steps: Ad-referendum endorsement of Revised ARES

<u>June – July 2023</u>

- Revised ARES will be re-circulated to Meeting delegates for final review and/or endorsement.
- Revised ARES will be circulated in parallel to both ASEAN Sectoral Working Group on Livestock (ASWGL) and ASEAN Health Cluster 2 (AHC 2) for review and/or endorsement.
- Revised ARES will be elevated in parallel to both Senior Officials Meeting of the ASEAN Ministers on Agriculture and Forestry (SOM-AMAF) and ASEAN Senior Official Meeting on Health Development (SOMHD) for review and/or endorsement.

[Note: Progress of consultations on Revision of ARES will be shared at 17th SOMHD in June 2023, as part of ASEAN Health Cluster 2 report]

Next steps: Ad-referendum adoption of Revised ARES

August - September 2023

■ Revised ARES will be elevated in parallel to both ASEAN Ministers on Agriculture and Forestry (AMAF) and ASEAN Health Ministers Meeting (AHMM) for adoption, through the facilitation of SOM-AMAF and SOMHD.

[Note: Progress of consultations on Revision of ARES will be shared at 44th SOM-AMAF in August 2023, as part of ASWGL report.]

Next steps: Implementation of adopted Revised ARES

(To be determined)

Conduct of consultation meeting between ASWGL and AHC 2 to formulate Revised ARES implementation plan, including among others discussion on the establishment of ASEAN multi-sectoral coordination body on rabies.

[Note: This may be guided by the operationalization of the ASEAN Leaders' Declaration on One Health Initiative to be adopted at the 42nd ASEAN Summit on 10 May 2023, and which deliverables include:

- Establishment of ASEAN One Health Network to strengthen multi-sectoral collaboration and coordination on OHI among AMS
- Development of ASEAN One Health Joint Plan of Action to improve regional and national capacities and capabilities]
